Kidnapping, (ACA §5-11-102);

Aggravated Robbery (ACA §5-12-103); or

Delivery of controlled substance to a minor under ACA §5-64-410.

5. This court accepts the plea and enters a judgment of guilt and,

a. Commits the defendant to Arkansas Department of Correction for a term of \_\_\_\_\_ with judicial transfer to the Arkansas Department of Community Correction; **OR**

b. Suspends the imposition of sentence for a period of \_\_\_\_\_ years, with or without supervision; **OR**

c. Places the defendant on (supervised) (unsupervised) probation for \_\_\_\_\_ ; **OR**

d. Sentences the defendant to \_\_\_\_\_ in the county jail for a misdemeanor committed after January 1, 2007.

6. The defendant is sentenced under Act 531 of 1993, as codified at A.C.A. § 16-93-1201 et seq.

7. At the end of the term provided for in paragraph 5 above, the Court will review the defendant's compliance with the Court's terms and conditions.

8. If the defendant has successfully fulfilled the terms and conditions set forth above, upon application, an order may be entered expunging the conviction of the defendant.
